Whole School Code of Behaviour Policy

This Whole School Code of Behaviour Policy Document
was ratified by the Board of Management on Thursday, 13th June 2024

This Code of Behaviour Policy document was ratified by the Board of Management.

Our school encourages hard work, collegiality, and mutual respect. Our Code of Behaviour is designed to maintain a Christian environment in which the student learns self-discipline, personal responsibility, and an acute awareness of the rights of others. Our aim is to administer it with fairness, understanding and compassion but to ensure that the principles of natural justice are always applied.

This Code of Behaviour is an important document espousing excellence in behaviour and conduct by all members of the St. David's Holy Faith Secondary School community. In the event of incorrect behaviour by students, this policy outlines clearly the rules and regulations to be followed for and by students. All students of St. David's Holy Faith Secondary School, Greystones, by being students, agree to follow rules and regulations stipulated in this policy. This policy, along with our Substance Use and Suspensions and Expulsion policies, form the classroom code and behavioural management for students.

These guidelines are not a definitive list of all our school rules, and school management reserve the right to interpret what constitutes a breach. The School's full Code of Behaviour and Substance Use can be found on <http://www.stdavids.ie/>.

Attendance:

It is the responsibility of parents/guardians to ensure that their child attends school regularly and on time to achieve maximum results in our school.

Progress at school requires optimum attendance and punctuality, therefore:

- **Procedure in the event of a student being absent:** A signed and dated note or email from a parent(s)/guardian(s) to the school office is required to explain absences
- **Procedure in the event of a student being late:** A student must present a note when reporting to the school office when late. If the student does not have a note, a phone call or email from parent(s)/guardian(s) that same day is required. If none of the above are provided that school day for a first offence, a two hour detention is imposed in the first month. For a second or subsequent offence, a one day suspension is imposed automatically, for the subsequent month
- Students must obtain permission from school authorities if they need to leave school during school hours. A note from a parent(s)/guardian(s) must be presented at the school office in order for permission to be sanctioned. Please make such medical/dental appointments outside of school hours, where possible. Under no circumstances should a student leave the school premises without signing out at the office.

Respect for one another:

Each member of the school community must remain conscious of the rights and responsibilities of all to enjoy and to contribute to a safe and effective learning environment:

- As St. David's Holy Faith Secondary School is a co-educational school, boys and girls must show mutual respect at all times to one another
- Students must not bully or intimidate fellow students. Cheating, bad language, dishonesty or unruly behaviour will never be tolerated

- Aggression, verbal or physical, is absolutely forbidden
- Any form of harassment, verbal, non-verbal, physical or sexual, will always be severely sanctioned
- Sexual interference with, or abuse by word or deed, of another student is completely unacceptable and may result in expulsion, in accordance with the procedures laid down by our school as per our Anti-Bullying Policy ratified by the Board of Management.

Interaction with staff:

Each member of the school community must recognise the responsibility of staff, who in the interest of all, must implement the codes and practices of the school in an atmosphere of mutual respect and to ensure maximum academic achievement.

In order to facilitate learning and teaching:

- Students are required to show respect and abide by staff instructions at all times in class, on the school premises, on outings and at functions. Bringing our school into disrepute will always be considered a serious breach of the Code of Behaviour and a serious sanction will always apply
- Students must have all books and equipment necessary for class and for students with permission to use digital devices, they must have for all classes
- Students are required to be punctual for all classes and to move quickly from one class to the next
- Homework must be completed and submitted as directed
- Disruptive behaviour in class will never be tolerated. Teachers must be allowed to deliver the curriculum and students to learn, in a calm and orderly environment, to ensure maximum academic achievement
- Sexual interference with, or abuse by word or deed, of a member of staff or visitors to the school is completely unacceptable and may result in expulsion.

Incidents of violence towards staff will be firmly dealt with in accordance with the guidelines set out in Circular M18/99 as issued by the Department of Education, and in conjunction with the school's Suspensions and Expulsions policy.

Safety and Health:

The school promotes a safe and healthy environment and so sees the safety of all staff and students as paramount:

- Students must avoid any action which could cause physical, emotional or psychological injury to any other person in the school. If so, as per this Code of Behaviour policy, disciplinary action may include sanctions up to and including expulsion
- Students must never smoke or have cigarettes, e-cigarettes, nicotine pouches, snus, vapes, lighters or matches in the school or on the school grounds or when participating in any extra-curricular activity or at any time while wearing the school uniform. If so, as per this Code of Behaviour policy, disciplinary action will result in suspension. This also confirms and is linked with the school's Substance Use policy
- Aerosols (especially spray deodorants) laser pens, and other such items can be dangerous and therefore, students must never use or have these in school or on the school grounds
- Drinking alcohol or being in unlawful possession of alcohol in school or on the school grounds or when participating in any extra-curricular activity is forbidden and is liable to serious disciplinary action, up to and including expulsion
- The possession, use, promotion for sale, or sale of solvents or controlled drugs is forbidden and liable to serious disciplinary action, including as stated in the school's Suspension and Expulsion

policy. With regard to alcohol or controlled drugs any such breach of discipline will also be reported to the Gardaí as per this Code of Behaviour policy

- Being in possession of a weapon, or using any potentially dangerous object as a weapon, will be treated with the utmost severity and will be reported to the Gardaí and full rigours of this Code of Behaviour put in place. Such a case will be liable to serious disciplinary action, with sanctions to include suspension and/or expulsion
- Searches of students lockers will be conducted if applicable, and only in circumstances where it is deemed necessary. Such searches will be conducted in the presence of the Deputy Principals/Principal or appointed person, such as Year Head
- Interference with any safety equipment such as fire extinguishers, defibrillator or alarms is a very serious matter and will be dealt with accordingly, as per this Code of Behaviour policy, and such behaviour is liable to serious disciplinary action, up to and including expulsion.

Property:

Each member of the school community must be conscious of our responsibility as citizens and of the need to respect our environment and all property:

- Students must not damage or interfere with property belonging to the school, the staff, other students or visitors to the school
- It is expected that all students will contribute to the maintenance of a clean environment at all times. Disposal of food or litter must be placed in bins provided
- Chewing gum is not allowed in school
- In the interests of a graffiti free environment, permanent markers and aerosol spray paints are strictly forbidden
- The Schoolbooks Scheme for Junior Cycle in Post-Primary Schools was introduced by the Department of Education in March 2024. This scheme provides students at Junior Cycle with free books and materials for their use. These books are the property of the school and, as such, need to be submitted back to the school at the end of May each year. All parents and guardians will sign a document outlining the books they have acquired, their bar-codes and an agreement to pay the cost of any lost or damaged books. This document will be kept on file in the school as a record of what was given to each student. In addition, please see the Junior Cycle Book Scheme and Stationery Provision Policy, 2024-2025 on the website at www.stdavids.ie.
- Mobile phones, music players, EarPods, smart watches and electronic games systems may only be used prior to the commencement of tutorial, at the mid-morning break and during lunch time and must be switched on silent at all other times, unless stated by their teacher. In the event that a mobile phone goes off or a student is caught texting/phoning without permission, the phone will be confiscated by their teacher who will then give it to the student's Year Head. The phone will be confiscated for seven days and returned on the eighth day. If this falls on a holiday or a week, the phone and/or device will be returned day in which school re-opens, meaning it may be longer than the seven days.
- The taking of photographs or photographic images by students of staff member(s), student(s), visitor(s) to the school, school events by any media e.g. camera phones, cameras, camcorders etc. is prohibited, unless permission is obtained from the teacher(s), student(s), event organiser(s), school authorities. This refers to both on the school premises and extra-curricular activities/events off the school premises. Any breach of this regulation will be considered a serious breach of school discipline and may lead to a severe sanction. This is outlined in the school's Acceptable Use policy

- The posting of any images or information (real or alleged) by students(s), of any teacher(s), student(s), school event(s), visitors to school, whether on the school premises or in an extra-curricular setting off school premises, in any medium be it print, T.V. internet sites, camera phones or any other medium is strictly forbidden, without permission of the teacher(s), student(s), visitor(s) to the school, event organiser(s), school authorities. Such posting of unauthorised image(s)/information is a serious breach of school discipline and may lead to a severe sanction, up to an including expulsion and/or suspension.
- Toilets – there is to be no loitering in the toilet area. If leaving a class to go to the toilet the student must ask the teacher first and present their homework diary, opened on the correct page, for teachers to initial and insert the time of going to the toilet. Students must also leave their mobile phone face down on the teacher's desk.
- The school toilets have vape sensors installed. In the event that the sensor is activated the school will conduct an investigation through the review of CCTV cameras at that time. If the vape sensor is activated when a student(s) are in the toilet and no admission of vaping, then it will be assumed that student(s) were vaping. If there is more than one student all students in the toilet will be assumed vaping.

Uniform/Hair/Jewellery:

It is the responsibility of parents/guardians to ensure that their child/children are in full uniform, no exceptions to this rule is permitted. It is also the responsibility of parents/guardians to ensure that:

- Students respect our school's uniform and appearance code.
- The school expects that students take pride in their appearance and that they promote the good image of the school by wearing their uniform correctly. Students know that their uniform is a badge of belonging.
- Only badges/insignia approved by the school authorities are permitted on uniform both indoor and outdoor.
- Students must wear the formal school uniform and school P.E. uniform on designated day(s) of P.E. The uniform, as indicated on the uniform list, and posted on our website, conforms to the requirements of the Equal Status Acts 2000 - 2015.
- Students must wear their school jumper in school, at all times. During warmer months students are allowed to remove their jumper in class, but once they leave class, they must put their jumper back on.
- Students must wear black walking shoes, no runners/trainers of any description are permitted, with the exception, during day(s) of P.E. Under no circumstances are students to come to school without wearing their black shoes. It is not an accepted excuse that black shoes have been ordered online or are awaiting delivery to shop or home or are damaged or damp. Students will be sent home and not permitted in school until they are wearing their black shoes. Students are permitted to wear their P.E. uniform to and in school, during the days in which they have P.E. class.
- For students wearing school trousers, the hemline length of the trousers must reach the level of their shoes. For students wearing the school skirt, the hemline length of the skirt must reach the knee.
- For all year groups the only jacket permitted is the school crested, black jacket.
- Students are only permitted to wear black socks or black tights - no other colour is permitted.

- If a student arrives to school without a school tie, their phone will be handed into the office and they will be given the tie for the duration of the school day after which their phone will be returned to them upon returning the tie at the end of the day.
- Whilst wearing their school uniform, students' conduct on buses, trains and elsewhere in public, must be in accordance with the school's code of behaviour. In addition, please see the Trips and Tours Policy which is at www.stdavids.ie.
- Losing items of school uniform or having items of uniform in the wash will not be considered an excuse for failing to arrive to St. David's properly attired - students will be sent home and will only be permitted back to school in their full uniform.
- Body piercing is never permitted under any circumstances. This includes face, tongue, nose, eyebrow, lip piercings, ear cartilage. Students are permitted to wear one small discreet stud/earring on each lower ear lobe. Students are never permitted to wear the following:
 - Bling studs
 - Ear gauges such as plugs, tunnels or any other form of earlobe stretching jewellery
 - Hoops
 - Upper ear cartilage earrings

In the event that a student wears any of the above banned piercings, these items will be confiscated by the Deputy Principals and not returned to the student until the end of the academic term. If a student refuses to co-operate and abide by said school rules, they will be sent home, and not permitted to return to school, until they accept these policies. It is the responsibility of parents/guardians to ensure that their child abides by these rules and regulations. In the event of a second or more offence(s), an automatic suspension may be imposed

- No unconventional haircuts or hair dye(s) are permitted
- No fake nails, eyelashes or eyelash extensions permitted. Students will be sent home and can return to school once removed.
- Tattoos – no visible tattoos are permitted. Any student presenting with a visible tattoo will need to have the tattoo formally covered up at all times.

Supports and Sanctions:

The Principal, Deputy Principals, Year Heads and all teachers are here to support and encourage all students. Every effort is made to adopt a positive approach to behaviour in school.

The school has one counsellor who is available to students. The counsellor will involve other support agencies as required or appropriate, in consultation with parents.

Overall, responsibility for discipline in the school is vested with the Principal, who is charged with ensuring that the school's Code of Behaviour, is administered in a manner which is consistent and fair to all students.

Each teacher has responsibility for maintenance of discipline within his/her class while sharing a common responsibility for good order within the school premises.

A written record of all instances of serious misbehaviour is maintained, and shared with all parties (students and parent(s)/guardian(s)). The normal channels of communication between school and parents/guardians are utilised and the active co-operation of parents/ guardians is sought in helping a student who has disciplinary problems to change their behaviour.

Refusal to comply with school rules will result in disciplinary action for the common good as per this Code.

Strategies and Sanctions:

The following are some of the strategies as outlined in this Code of Behaviour policy, which may be used to deal with unacceptable behaviour:

- Talk with students, to explain why the behaviour was unacceptable and how to improve
- Loss of privileges
- Payment for the repair or replacement of damaged property
- Confiscation of inappropriate or distracting items or materials. Games systems, mobile phones, iPads etc. are confiscated for one week (seven days inclusive)
- Detention by subject teacher, with parents/guardians notified via the official homework journal/letter/phone call
- Detention by Year-Head, parent(s)/guardian(s) notified by letter
- Detention by Deputy Principals for 'lates' (first offence) whereby no note/email or phone call on day of 'late' is not received and one day suspension in event of second or subsequent day late without a note/phone call/email from parent/guardian
- Student put on daily/weekly report to Year-Head
- Referral to Principal/Deputy Principals

Suspension from school:

All suspensions are imposed by the Principal and notified to the Board of Management. Automatic suspension ensues for smoking/use/possession of drugs, use of cigarettes/snus/nicotine pouches/vapes/e-cigarettes or alcohol. This may be followed by further sanctions in the case of drugs, alcohol, defiance, active aggression and 'lates' (without same day note/email/phone call for second or subsequent time). Where a suspension is for longer than five days, the Board of Management will review the situation and decide:

- to allow the student return on probation, or
- to continue the suspension for another period, or
- to impose conditions for the student's return, or
- to request parents/guardians withdraw the student from the school, or
- to consider a refusal of re-registration, or
- to expel the student.

If a student's behaviour involves repeated suspension, such a student, with their parent(s)/guardian(s) may be interviewed at a disciplinary meeting consisting of his/her Year-Head and the Principal and/or Deputy Principals. At this interview, the student and parent/guardian will be clearly and formally warned by the Principal and/or Deputy Principals that, should the student's behaviour not improve, the Board of Management will be asked to review their continued presence in the school.

Section 29 of the Education Act 1998 gives parents/guardians and students, who have reached the age of eighteen, the right to appeal suspension for a period which would bring the cumulative period of suspension to twenty school days in any one school year to the Secretary General of the Department of Education.

Expulsion is most serious disciplinary sanction and will be resorted to for gross misconduct, the use and sale of forbidden substances, including drugs and alcohol, sexual harassment and other serious breaches of this Code of Behaviour and Anti-Bullying policies.

If it is proposed to expel a student, St. David's Holy Faith Secondary School will notify the education welfare officer, in accordance with the requirements of the Education Welfare Act 2000.

Parents/guardians will be given the opportunity to meet with the Board of Management, to hear the complaints against their child and to give a written and/or oral response to the Board of Management. Parents/guardians, if they wish, may bring a representative with them to this meeting.

In the event of a student being expelled, the student (if over the age of eighteen years), or if (the student is under eighteen years) his/her/their parents/guardians shall have the right to appeal the decision to the Trustees and under Section 29 of the Education Act 1998, to the Department of Education.

Furthermore, a student shall not be expelled from the school before the passing of twenty school days following receipt of notification by the Education Welfare Board, as stated above.


The Board of Management reserves the right to take such other reasonable measures as it considers appropriate to ensure that good order and discipline are maintained in our school and that the safety of students is secured.

Any of the above sanctions, or a combination of them, may be implemented depending on the gravity of the offence.
